I am the above named person and live at the address I provided to police. I have lived at the address for two years with my boyfriend Martyn DICK. I have been in a relationship with Martyn for about 3½ years. [REDACTED]

I currently work in [REDACTED] I have (been) there for about 8 months.

Martyn works as a [REDACTED] when he works as a [REDACTED] he is employed by a company which I think is called [REDACTED] and run by a guy called [REDACTED], I don't know his surname.

Martyn is friends with a guy called Shek, his real name is Sheku BAYOH, he is of West African descent and lives in Kirkcaldy. I am not sure how long they have been friends, but Martyn has known Shek as long as I have known him. I am not sure how they met, but it might have been at the gym or through friends, they both go to the Templehall Gym in Templehall Kirkcaldy.

Martyn is also friendly with a guy called Zahid SAEED who I think is staying with his mum in [REDACTED]. I'm not sure where he is staying at present, [REDACTED] but I am not sure. Zahid is not going through the best of times, [REDACTED]

As far as I know Zahid works in [REDACTED] I have known Zahid for about two years, but I think Martyn has known him longer.

As far as I know Shek and Zahid have been friends for many years, since they were teenagers.

Martyn would see Zahid on an irregular basis, Zahid would usually pop into [REDACTED] when Martyn was working after he finished his work or sometimes he would pop round to the house. Martyn would see Shek occasionally, he would not see him very often. Martyn has only seen Shek a couple of times in the last few months, mainly because Martyn works two jobs and is usually tired when he gets home.

About five o'clock (1700 hours) Saturday 2nd May 2015, myself and Martyn dropped our dog off at my mum's house in [REDACTED]. Martyn then dropped me off at [REDACTED] about ten to six (1750 hours) and then went to work at [REDACTED].

I left [REDACTED] at ten to two (0150 hours) Sunday 3rd May 2015, I got a lift from a member of [REDACTED] staff [REDACTED], not witness meantime) and we went to McDonalds at John Smith Retail Park in Kirkcaldy. We sat in and had something to eat. [REDACTED] dropped me off at about twenty to three (0240 hours). When I got home I paid for the Mayweather V Pacquiao fight on Sky box office [REDACTED].

Martyn got home about quarter to four (0345 hours) we put some food in the oven to eat when we were watching the fight. About this time Martyn got a text from Zahid which said something like "we're on our way up dude, is that ok", there was a loose arrangement between Martyn and Zahid from him to come to the house and watch the fight. Martyn agreed for them to come and watch the fight, but warned them that he might not be great company as he was really tired.

I am not sure which time Shek and Zahid arrived but the warm up fight was on round 8, but I had paused the live TV on Sky. [REDACTED]

[REDACTED] I think Shek had been drinking as he brought a bottle of some alcoholic liquor called Parrot Bay with him. [REDACTED]

I was sitting in the living room talking to Shek, he was chatting away and showing me pictures of his baby on his phone, at this point Shek appeared fine. Whilst I was

speaking to Shek, Martyn and Zahid were in the kitchen whilst Martyn sorted the food out. At that point Shek went through to the kitchen and joined Martyn and Zahid, at that point I was sitting alone in the living room, the three of them then came back into the living room and sat down.

I was sitting on the end of the settee nearest the stairs, Martyn was sitting on the other end of the couch, Zahid the came and sat on the settee in between Martyn and me, before that he had been sitting on the recliner. At this point Shek was sitting on the seat which is underneath the stairs in the living room.

As I spoke to Shek I got the impression that he had taken some type of controlled drugs, I noticed that he was ringing his hands and appeared nervous. I know the signs of people who are under the influence of drugs from working in [REDACTED]

I gained the opinion that Shek may have taken MDMA, as I have heard of him previously taking MDMA and I also heard him making a comment that the MDMA was shit. Shek appeared paranoid and continually thought we were talking about him, but we were genuinely not talking about him. I found it very unsettling, as every conversation we were having, Shek believed that we were talking about him.

Zahid and Martyn were trying to reassure Shek that nobody was talking about him but he was very confused. I am not sure how long this went on as I don't have a great concept of time in the house. Zahid continued to try and reassure Shek that nobody was talking about him, and was trying to get him to go outside and get some fresh air. Shek would not believe what Zahid and Martyn were saying to him.

Suddenly, quite out of the blue, Shek has stood up and said "SORRY, I HAVE COME INTO YOUR HOUSE TO WATCH THE FIGHT AND HAVE NOT OFFERED YOU ANY MONEY FOR IT".

I told him that we did not want any money from him and only wanted him to feel happy and comfortable in my home.

At this point Shek has put on his zip up hoody and left the house by the back door from the kitchen. A few minutes later Zahid went out after him, thinking that Shek maybe waiting at his car, Zahid returned to the house about five minutes later asking is Shek had come back.

Martyn told Zahid that Shek had not come back and Zahid then left to go looking for Shek. [REDACTED]. About five minutes after that Zahid phoned Martyn and said he couldn't find Shek. Martyn explained to Zahid how Shek would walk back to his house from our house, and told Zahid to [REDACTED] at the top of Sheks street and he would see him coming. As Martyn was on the phone to Zahid, Zahid said he could see Shek coming, Martyn said let me know if he is ok and then said cheerio to Zahid.

Later that morning Martyn noticed he had 8 missed calls on his phone from Zahid, and a text message from him saying "HELP ME". Martyn then called Zahid back and

Zahid told him that Shek had attacked him and had chased him and that Zahid had managed to get away from Shek.

Martyn got Zahid to calm down and has then [REDACTED]
[REDACTED]. Martyn [REDACTED] Zahid at flats on Fair Isle Road ,
and [REDACTED] Zahid round to the area where Shek stays to get [REDACTED].

A short time later Martyn called me to say that he was coming home, and Zahid was [REDACTED].

When they got back I was in bed, Martyn and Zahid were downstairs in the kitchen talking. A short time later Martyn came and asked if he should contact Sheks partner (Collette BELL) and tell her what had happened, Collette was spending the night at her mums with the baby.

I said he definitely should, as she would have no idea what she was walking into, and we did not know what frame of mind Shek would (be) in.

Martyn went back down and Zahid sent a text to Collette, and she called him back and Zahid explained to Collette about how Shek had been acting, but I don't know exactly what was said or to what degree.

A short while later Zahid left and Martyn came up to bed, he told me that Zahid had told him that Shek attacked him from behind as he left Sheks house, and that Shek had thrown a clothes pole at him, and that he had him down on the ground attacking him, but Martyn didn't go into any further details.

Martyn and myself then went to sleep and we got up at one o'clock (1300 hours). About ten minutes later the police came to the door and explained they were investigating a serious incident involving Shek. We agreed to handing over the house keys to the police to enable a possible forensic examination of the house. I then went to Kirkcaldy Police Station and provided a statement to police.

I probably should have said before but Shek is a regular gym user and I think that he might be a user of anabolic steroids. Martyn has previously used them and he and Shek previously trained together regularly at the gym.

All the time have I have known Shek I would say I have never seen him the state of mind he was last night, how he was last night was very out of character for him.

I would describe Shek as male, black African, 5'10"-5'11", large build, muscular, shaved afro hair, clean shaven, no scars or tattoos, wearing dark, zipped hooded top, white top underneath. Nfd..

This is a true and accurate account.

Last night I was wearing a pair of grey Adidas tracksuit bottoms and a grey round neck t-shirt and a black hoody with red, yellow and green letters on it and purple socks.

They are on the ironing board in the kitchen.
