Critical Incident Communications Strategy – The death of Sheku Bayoh (Kirkcaldy)

#### 1. Purpose

To outline an integrated communications strategy that supports the objectives of the Gold group established to oversee the Police Scotland response to the ongoing investigation into the death of Sheku Bayoh, who died following police contact in Kirkcaldy, Fife, on Sunday 3 May, 2015.

#### 2. Aim

The terms of reference for the Gold group aim to maintain confidence in Police Scotland. Specific terms include:

- Develop and implement a strategic internal and external communications strategy
- Identify priorities for improvement to ensure any organisational learning

This strategy aims to support the policing response to the inquiry into the death of Sheku Bayoh with a consistent set of messages and communications that supports internal and external confidence in the service.

#### 3. Objectives

 Work with PIRC and COPFS to ensure the timely provision of external information as appropriate

- Engage with partners including the Scottish Police Authority (SPA),
   Scottish Government and others as appropriate to ensure provision of timely information
- Provide internal communications to support officers and staff with regular updates and tailored messaging as relevant, with particular regard to the affected local policing teams and individual officers
- Provide messaging to officers and staff to equip them to confidently update partners or the public if they are asked about any aspect of the response through SMT briefing area
- Ensure family and significant witnesses are kept informed in a timely and appropriate manner
- Ensure social media updated with timely information at local and where relevant, at national level
- To be aware of relevant events (local and/or national) that may impact on perceptions regarding the incident

#### 4. Key audiences and Stakeholders

The limited communication immediately following the incident led to a gap in information and over following weeks and months, substantial speculation and reporting from various unnamed sources and also subsequent criticism from the deceased family's lawyer.

Events have resulted in a significant level of external scrutiny and interest and it is a priority to manage public and stakeholder interest in this incident in the context of that environment.

Key stakeholders include:

Police Scotland officers and staff Senior leaders within Police Scotland Scottish Police Federation Association of Scottish Police Superintendents Diversity staff associations Members of the public PIRC COPFS Scottish Cabinet Scottish Government Elected representatives, MSPs and MPs Fife Council and locally elected representatives SPA Scottish Police Authority Local community groups incl Frae Fife Media

Contact with the family of the deceased and the families and officers affected is also important.

Regular reviews and local community impact assessment will ensure this impact is regularly monitored.

#### Key messages/narrative

Key messages around this incident were restricted to expressing condolences to the family and friends of the deceased and referring to the ongoing PIRC investigation. Messages have been and will be developed as events dictate, specifically the anniversary of the death, PIRC passing report to COPFS, and the FAI and any other legal proceedings civil or criminal.

These messages will seek to reassure that we are supporting all who need this and are fully committed to the procedures involved in establishing what happened, and outlining the process to shape expectations. Whilst investigations and legal proceedings are in train we are limited in what we can say so as not to influence or prejudice the same.

The general messages have been versions of the below -

Deputy Chief Constable Fiona Taylor said:

Our thoughts remain with Sheku Bayoh's family and friends following his death three years ago, and we continue to offer support to anyone affected by this tragic incident.

Police Scotland has been committed to cooperating with the PIRC and the Crown Office throughout the investigative process, and whilst this continues we cannot comment further.

#### Tactics

A range of communications tactics will be deployed as appropriate. For our internal audiences, these will include use of our existing internal communication channels as well as face to face communication with directly impacted teams.

Going forward, regular engagement and updates will be required with key partners and the Scottish Police Federation.

A communications action log will record all planned activity.

#### 7. Risks

The events of May 2015 and the ongoing PIRC/COPFS investigation present a risk to maintaining public confidence in policing. Clear and timely communication will assist with mitigating the impact of this however this has been restricted by the ongoing investigations.

The deceased family's lawyer also represents members of the family of deceased who lost her life following the M9 incident in July 2015, and other high profile individuals. This has generated a common theme of criticism for the police.

The terrorist attacks in England in 2017, France in 2015 and the outcome of the EU Referendum in 2016 heightened interest in the media in hate crime, particularly racial or religiously motivated. The deceased family's lawyer represented a number of people involved in an incident in and has taken steps to publicise the number of hate crimes in Scotland since the atrocities in France. The Black Lives Matter movement saw growth in momentum in the UK.

Confidence in policing in general has been a recurring theme, following the inquest into the deaths of Liverpool football fans at Hillsborough in 2016. The deceased's family lawyer has drawn this comparison with the lack of answers whilst the PIRC investigation continues a year after the death. This criticism has been levelled more at the PIRC than Police Scotland, with messaging demonstrating our commitment to assisting with their inquiry.

Questions have been raised regarding the integrity of various police officers in the Kirkcaldy incident, impacting on morale and undermining public confidence and leaning towards an implication of wider institutional racism within the police. This issue should be addressed through work with Safer Communities to prepare for such a claim and a set of key messages prepared to respond to any future criticisms.

Either maintaining full pay or reducing pay has a risk to morale of officers and to the reputation of the force concerning public funds, and clear and directed messaging has been developed to mitigate these risks in various quarters.

Complaints have been lodged by persons indirectly involved with the incident itself, these are being handled by PSD and media do not appear aware of these at this time.
